

Now we're doing it right and big. Real companies, sustainable revenue streams, and a structure that stays true to what made us strong: everything for the community.







# Secured Tokens & Liquidity

The majority of the tokens earmarked for the company, sales agency, taxes, and branding will be backed by a vesting program to ensure long-term commitment and stability. For more information, please consult the "Locks" section of our menu.

Liquidity on decentralized exchanges is pegged to Wrapped Bitcoins, which means that the price of BAGX Tokens is directly affected by Bitcoin's performance. Our enthusiasm for Bitcoin and its underlying technology is so great that we want to reflect its success in our own market performance.

# Dividend & Transparency

Every six months, we publish a detailed report outlining all income and expenses, ensuring full transparency–a practice familiar from our BlockRock days. These reports include all team and company wallets, making them auditable at any time.

In addition to buybacks and token burns, Bros & Gains offers dividend payouts. A portion of the revenue-whether from transaction fees, merchandise sales, or crypto trading profits-is allocated to a special savings account. At the start of each half-year, you can stake your BAGX tokens in our dividend wallet to earn attractive distributions. Your dividend depends on two factors: the revenue generated and the number of tokens you stake for the next six months.

After six months, you'll automatically receive your staked tokens along with your dividend. Better yet, the next staking cycle begins immediately, allowing you to continue earning without interruption. Let your BAGX tokens work for you!


